

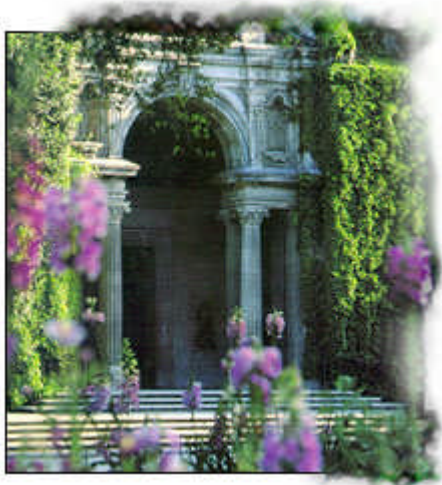

Frederick Burwick (UCLA), former Executive Director (1978-1981) and past President of PAMLA (1997-1998), has published an edition of Coleridge's long lost translation of Goethe's *Faust* (Oxford University Press, 2007). ## Report on the Executive Board Meeting, Western Washington University, Bellingham, WA



The Executive Board met on November 1, 2007 from 6 p.m. to 9.30 pm at the Lakeway Inn, in Bellingham, Washington. Members present included President Kathleen Lundeen, First Vice-

President Imke Meyer, Second Vice-President Beverly Voloshin, Pacific Coast Philology former Editor Victoria Myers, new PCP co-editor Lorely French, and Executive Director Salah Khan. The Executive Committee Officers present were Hans-Jürg Rindisbacher, Andrea Gogrof-Vorhees, Leila May, Victor Castellani, Beverly Voloshin, Heidi Schlipphacke, Andrew Fleck, Catherine Montfort, and Graduate Student Representative Eydie Fernandez.

Kathleen Lundeen called the Executive Board meeting to order. As the Site Chair of this year's conference, she began by thanking Western Washington University for its generous support. The President then presented the status of the 2007 PAMLA Conference.

After approval of the November 2006 Board Meeting minutes, the Executive Director announced the election results. This year, 20% of the members cast their ballots. This constitutes a 4% increase over the 2006 vote. Thierry Boucquey (Scripps College) was elected Second Vice President. Imke Meyer (Bryn Mawr College) will become President, and Beverly Voloshin (San Francisco State University) will become First-Vice President. Stanley Orr (University of Hawaii, West Oahu) and Catherine Montfort (Santa Clara University) were each elected to the Executive Committee for a three-year term. Pauline Beard (Pacific University) will serve as co-editor of *Pacific Coast Philology*. Mary Song (University of California, Riverside) was elected Graduate Student Representative.

Salah Khan presented the results of the 2007 PAMLA Graduate Student Scholarship program. 21 applications were evaluated this year by the committee. All the funds were once again allocated according to a two-tiered evaluation system that took into consideration distance traveled and merit, with the dual goal of supporting excellence in scholarship and reaching out to as many graduate students as possible. The program continues to be a

remarkable success. The drawback of this achievement is that less money is available overall to each applicant. Therefore, the Graduate Student Scholarship program relies more than ever on the generosity of our members. In 2007, \$895 was available for scholarships. Money awards and conference registration fee waivers were awarded to 9 applicants. All other applicants received conference registration fee waivers. Total awards ranged from \$145 to \$25.

The Executive Director presented the 2006-2007 Financial Report which the Audit Committee approved. The closing balance remained relatively stable at \$15,314.92, (a decrease of \$1023.88 over last year). The committee agreed to increase membership dues by \$10 across the board. There will be no increase in conference registration fees. Membership runs from conference to conference and members should look for renewal forms in their conference packets and in the February 2007 newsletter. A form to download is also available on the website.

During the General Editor's *Pacific Coast Philology* report, delivered in absentia, the Board was reminded that \$3,905.63 from PAMLA's general fund has been earmarked to help pay for the 2007 special issue of PCP. The current journal balance stands at \$2,285.96.

Eydie Fernandez, Graduate Student Representative, was thanked for her diligent volunteer work on the PAMLA's previous webpage. A report from Heather Wozniak—who volunteered to assist in updating and redesigning the website—was distributed and discussed. Heather Wozniak modernized the layout, colors and fonts; added dropdown menus to aid in navigation; and converted more DOCs and PDFs to webpages so that information is available online without having to download the various documents. Among other features the Executive Committee will consider in the future include a Content Management System, a Discussion Board or Forum, and Custom Email addresses. The Executive Committee expressed concerns over the issue of privacy connected to

establishing a listserve of all PAMLA members.

A proposal from the Executive Director to automate memberships, conference registrations, and abstract submissions was warmly greeted by the Executive Committee. The Committee endorsed the addition of an online option for PAMLA members under the condition that confidentiality will be assured by the host company.

A proposal to change the name of PAMLA's journal did not receive strong support from the committee and was turned down.

In coordination with the 2008 site chair Hans-Jürg Rindisbacher, the First Vice-President Imke Meyer presented a forecast for AV costs and budget for the 2008 conference in Pomona, California. No overruns are expected due to the healthy conference funding pledged by Claremont College and Bryn Mawr College. Hans-Jürg Rindisbacher and Imke Meyer will serve as co-hosts for the 2008 conference. Both the February newsletter and the website will contain the Call for Papers.

It is anticipated that the 2009 conference will be held at San Francisco State University, in California. Beverly Voloshin will serve as Chair of the On-site Host Committee.

The 2006-07 Calendar was approved and the Job Descriptions were discussed. More details will be added this year to the job descriptions of President, Vice-President, and 2<sup>nd</sup> Vice-President.

## Report on the 2007 MLA Delegate Assembly, Chicago, Illinois.



The Executive Directors of all the regional MLAs are ex officio members of the Assembly with voting privileges. Besides holding governance elections, the Assembly passes resolutions that have the potential to affect many areas of the profession, and enacts changes in the MLA operations through motions. A resolution that the Delegate Assembly approves then goes before the MLA Executive Council for review, and then, if passed, is sent to all members to vote.

This year, the MLA Delegate Assembly met on Saturday, December 29, 2007 at the MLA convention in Chicago, IL. Elections were conducted of Delegates to the Delegate Assembly Organizing Committee: Brian Kennelly (California Polytechnic State University) and Gaurav Desai (Tulane University); a Delegate to the Executive Council: Alexandra Wettlaufer (University of Texas, Austin); New Members to the Nominating Committee: Timothy Hampton (University of California, Berkely), Paul Lutzeler (Washington University), Haun Saussy (Yale University); to the Elections Committee: Robyn Warhol (University of Vermont), Alan Nadel (University of Kentucky), Katherine Arens (University of Texas, Austin), Margaret W. Ferguson (University of California, Davis); and one Honorary Fellow: Albert Wendt, a Somoan novelist, poet, and playwright who resides in Hawai'i.

- One topic was addressed during the Open Discussion segment of the assembly: academic freedom.

The discussion revolved to a large degree around the question of whether the 1990 "Statement on Censorship and Academic Freedom" from the Committee on Academic Freedom and Professional Rights and Responsibilities should be updated to reflect the contemporary pressures on academics, their teaching, and their research. Also discussed were: standards of academic freedom; mechanics of academic freedom; and specific threats to academic freedom today. It was resolved that the Executive Council would pursue the revision of the 1990 Statement taking into consideration the 2007 Delegate Assembly's open discussion.

- Following the open discussion, Rosemary Feal presented the Report of the Ad Hoc Committee on the Structure of the Annual Convention. It was confirmed that the dates of the convention would be moved to the first Thursday following January 2. As a reminder, the early January Thursday to Sunday schedule is aimed to 1) take the strain off attendees' family December holiday plans; 2) have minimal effects on the job search, as most campuses are inactive during the week following the close of the convention on December 30; 3) minimize any disruption that might be caused to members who start immediately after the New Year. **Note:** given previously negotiated hotel contracts, the date change would take effect two years from now.

- The Ad Hoc Committee reported in detail on proposed changes to the structure and format of the annual convention. New formats will include, for example, roundtables which can accommodate up to eight participants and follow either the current arrangement of short presentations and discussion, or a new electronic version, with stations set up for one-on-one interaction. It was emphasized that new formats are choices, not obligations.

- A number of groups (Allied and Affiliate Organizations, Divisions, Discussion Groups, and MLA Committees) have guaranteed sessions at the convention. The Assembly voted to endorse the Ad Hoc Committee's proposal to solve the problem of impending gridlock in the convention structure: equitable allocation of session hours; fewer guaranteed sessions, but more opportunities to propose additional sessions.

- The Delegate Assembly then approved an amendment to article 4 of the MLA constitution to allow for voting by electronic means.

- Membership in 2007 was down by about .5% from the previous year. The total number of MLA members was 29,621, of whom 65% were regular members, 23% were student members, and 11% were life members.

- The assembly then heard the reports of the Executive Director Rosemary Feal, the Finance Committee, and the Standing Committees. 2007 was a year of general stability in terms of membership and finances.

- During the discussion of New Business, it was resolved that future committee reports should not be edited (except for minor matters of style) without consultation with the members of the committee.

- It was also resolved that the MLA defend the academic freedom and the freedom of speech of faculty and invited speakers to address the issue of the Middle East in the manner they choose.

- After extensive debate, it was resolved that the MLA condemns the University of Colorado investigation of Ward Churchill and all such politically motivated investigations into the speech and scholarship of faculty members throughout the world.

- Lastly, a resolution that the MLA publicly support state legislation aimed at ensuring fair pay and job security for contingent faculty and establishing a higher proportion of full-time faculty, as developed, in part, by the AFT-led campaign for Faculty and College Excellence was also approved.

## CALL FOR PAPERS

**2008 Conference in Pomona, California**  
**Friday and Saturday, November 7 and 8, 2008**

The 106th Annual PAMLA Conference will be held at Pomona College in Claremont, California, on 7 and 8 November. The local site committee is chaired by Hans-Jürg Rindisbacher assisted by Imke Meyer. We hope that you will propose a paper for this conference. Attached to these guidelines is the call for papers for the sessions. Please check the website for updates and corrections.

### **Guidelines and Procedures:**

Please follow the following rules and procedures pertaining to registering for and presenting papers at the conference.

### **Membership:**

\*PAMLA is an organization for its members. All participants in the conference should maintain current membership, which runs from conference to conference, that is, from November to November. Conference presenters and presiding officers should remit their dues by April 15 in order to be listed on the program. Information on membership is on the website at [www.pamla.org](http://www.pamla.org).

\*Interested faculty, students, or others not presenting or participating in the conference may attend the conference without being members of PAMLA. They must, however, pay registration fees, unless they are students at the host institution, in which case conference attendance is free.

### **Conference Registration:**

\*Everyone listed in the program must pay a registration fee. Registration materials will be sent

out in September, at which time conference fees will be made available.

**\* Please note: registration fees are separate from membership dues. \***

\*Students from the host institution who are not on the program may attend sessions and non-fee activities without paying the registration fee or membership dues.

### **Paper Proposals and Presentations:**

\*One does not have to be a member of PAMLA to propose a paper, but one must become a member by April 15 to be listed in the program.

\*A paper title, a 500-word proposal, and a 50-word abstract should be sent to the session chair by March 15.

**\*The same paper may not be submitted to more than one session.** Presiding officers may reroute a paper to a second session. More than one (different) paper may be submitted to different sessions, provided the presiding officers are informed at the time of submission. If you have papers accepted in more than one session, please decide immediately which one you will present, and notify both presiding officers, as well as the PAMLA Executive Director of your choice. If we discover your name in two sessions and we cannot reach you, we will choose your session for you.

**\*A member may preside over only one session, and may not present more than one paper at a conference.** The Executive Director and presiding officers shall resolve any conflicts that may arise.

\*Please notify the Presiding Officer and Executive Director if you cannot be present at the conference so that the program can be updated and a replacement found, if possible. While we recognize that emergencies arise, please make your plans as early as possible to attend or not to attend the conference. PAMLA would like to uphold the highest professional standards for its members and participants. Last-minute cancellations in the program, especially those that could have been conveyed early, do not bode well for the organization and the conference. Papers may not be read in absentia.

\*Conference sessions are ninety-minutes long, with three to four papers in a session. Each paper should be 15-20 minutes to leave time for introductions and discussion. Please observe this time limit when writing your paper.

All presenters who will need AV equipment are required to fill out the AV request form, available for the Presiding Officer of the session and on-line, and return that form to the P.O. by June 1. Presenters who request equipment later than that date will be responsible for equipment rental fees.

\*Please consider developing your paper into a publishable essay for *Pacific Coast Philology (PCP)*, PAMLA's annual refereed journal. Guidelines for submission are available on the website and at the conference.

### **Duties of Presiding Officers:**

\*Presiding Officers must be current in their PAMLA dues.

\*The Presiding Officer reviews paper proposals submitted by March 15 and selects three or four papers for that session. If the choice of proposals is limited, the P. O. is responsible for soliciting additional proposals from among colleagues, from

field-specific listserves, etc. The P. O. may not accept more than one paper from a colleague or a graduate student in his or her own institution. Consult the Executive Director for exceptions. **Normally, a P. O. may not read a paper in the same session over which he or she presides,** although exceptions are sometimes the case. Papers may not be read in absentia.

\*The Presiding Officer notifies all who proposed papers of acceptance or regrets by April 7.

\*The Presiding Officer must remind presenters to pay PAMLA dues by April 15 and that a conference registration fee will be due later.

\*The Presiding Officer sends session information to the Executive Director by April 15, including the names of presenters, their affiliations, and the 50-word abstracts of all papers.

\*Presiding Officers will receive an AV request form from the Executive Director and will send that form on to presenters. The form will also be available on-line. All presenters who will need AV equipment are required to fill out that form and return it to the P. O. by June 1. The P. O. will then send those forms on to the 2008 Conference site Chair, Hans-Jürg Rindisbacher. Presenters who request equipment later than that June 1 will be responsible for equipment rental fees.

\*At the conference, the Presiding Officer introduces the topic and the speakers, and moderates the session, controlling the time allotted to each speaker.

**\*At the conclusion of the session, the Presiding Officer of PAMLA standing sessions holds an election for a new P. O. and then sends that information (name and addresses for the new P. O.) to the Executive Director by December 1.** Please observe that deadline carefully, as the Executive Director needs that information for the next Call for Papers.

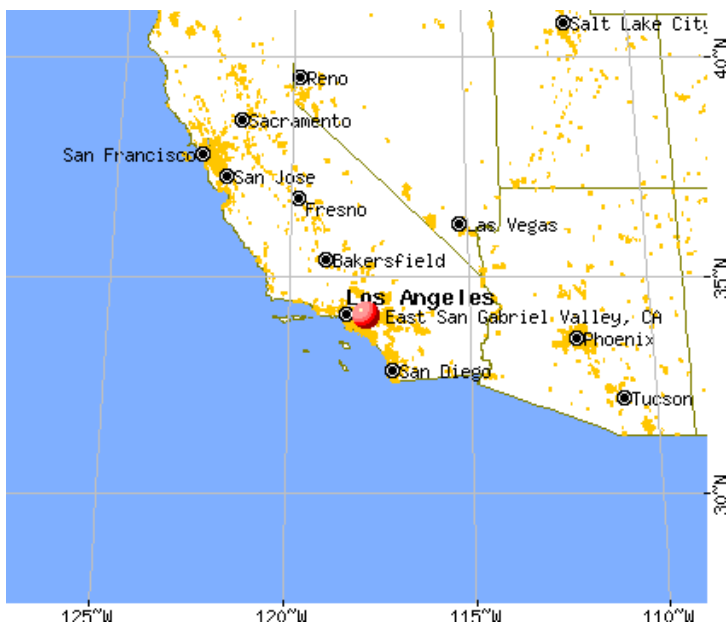

\*If the Presiding Officer is not able to come to the conference, he or she is responsible for notifying the Executive Director and for finding a replacement. As with presenters, there will, of course, always be emergencies that prevent attendance. Please make plans as early as possible to attend or not to attend the conference. The Executive Director assumes that only the direst emergencies will keep the Presiding Officers and presenters who have agreed to participate in the conference away from attending.

\*The Presiding Officer should encourage all presenters to develop their papers into publishable essays for *Pacific Coast Philology (PCP)*, PAMLA's annual refereed journal. Guidelines for PCP are available on the website and at the conference.

## Conference planning schedule

Due dates represent postmark dates for regular mail and e-mail submissions; allow adequate time when mailing overseas or to distant addresses by regular mail.

**March 15:** Proposals for papers for the 2008 conference at Pomona College due to the Presiding Officer.

**April 7:** Presiding Officer informs those who proposed papers of acceptance or rejection and receives confirmation from presenters that they can attend the conference. Presiding Officer reminds presenters to pay PAMLA dues.

**April 15:** Presiding Officer submits session information (name and affiliation of presenters; titles and 50-word abstracts of papers) to Executive Director, Salah Khan.

**April 15: All participants need to have joined PAMLA.**

**June 1:** Presiding Officers submit AV requests for presenters to Conference Site Chair, Hans-Jürg Rindisbacher.

**November 7 and 8:** Conference at Pomona College in Claremont, CA.

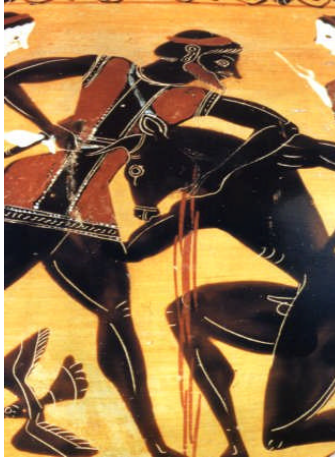
